BE IT FURTHER RESOLVED that the undersigned do hereby vote to levy or adopt the effective tax rate for Sutton County for the 2018 tax year at:

\$.563919 for the purpose of maintenance and operation.

This rate will raise more taxes and revenues for maintenance and operations than last year's tax rate. The property tax revenue to be raised from new property added to the tax roll this year is \$40, 431.

The Tax Assessor-Collector is hereby authorized to assess and collect the taxes of the County of Sutton, State of Texas, on this 25th day of September, A.D. 2017.


