RESOLVED BE IT FURTHER that the undersigned do approve to levy or adopt the tax rate for Sutton County General Fund for the 2025 tax year at **\$0.563712** for the purpose of maintenance and operation.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATION THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON \$100,000 HOME BY APPROXIMATELY \$167,441.78.

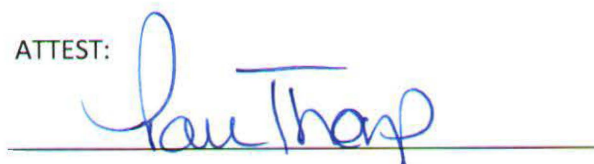

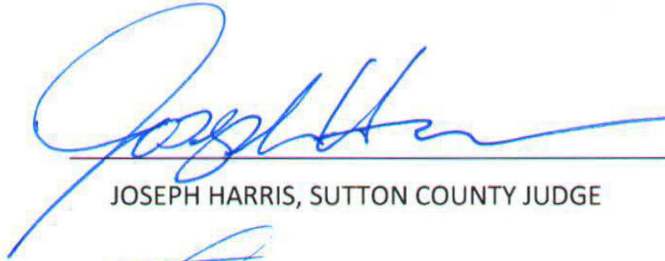
RESOLUTION LEVYING A TAX RATE FMFC FUND

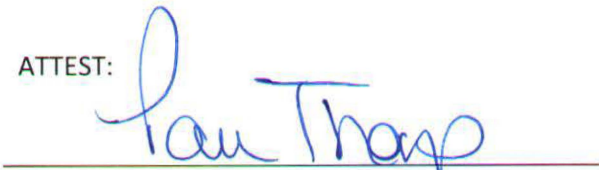
